Affirmation from 10-Year Residents of Pennsylvania

The Pennsylvania Child Protective Services Law and Catasauqua Area School District Policy #139 generally requires all volunteers to obtain and submit a report of Federal criminal history record information. However, the Law and Policy includes a limited exception to the federal report (but not to the required state criminal history record information report or statewide child abuse perpetrator database certification) for a person applying for an unpaid position who has been a resident of Pennsylvania during the entirety of the previous tenyear period and provides the following written affirmation:
